SUBJECT: Vacancy Announcement - Employee/Retiree Representatives to the GESC Health Insurance Board of Trustees

The Division of Personnel is in the process of conducting elections for the employee and retiree representatives to the Government Employees Service Commission (GESC) Health Insurance Board of Trustees. Title 3, Chapter 1, Section 6(b) requires that two employees of the Government of the Virgin Islands (one from each District), be democratically chosen by other Government employees to be appointed to the GESC Health Insurance Board. Title 3, Chapter 1, Section 6(b) further requires that two retirees of the Government of the Virgin Islands (one from each District), be democratically chosen by other retirees of the Government of the Virgin Islands to be appointed to the GESC Health Insurance Board.
