ELIGIBILITY REQUIREMENTS

Applicants must:

- Be licensed in the USVI or certified (as applicable) in their well-related field
- Demonstrate prior experience in planning and executing wellness programs
- Be in good standing with local and federal regulatory agencies
- Carry necessary liability insurance and meet background check requirements
- Be able to tailor content for culturally diverse, public-sector audiences

SCOPE OF WORK

Vendors must:

- Deliver one-time events or multi-session programming (e.g., 3-6 weeks)
- Provide all tools, handouts, or digital materials required
- Track participant engagement and/or collect feedback to demonstrate impact
- Coordinate with the Division of Personnel's Group Health Insurance/Wellness team for scheduling and promotion

PROGRAM LOCATIONS

Programs may be delivered:

- In-person at agency sites on St. Thomas, St. John, and St. Croix
- In outdoor community spaces where safe and appropriate, with adequate restrooms and parking (approval required for suggested spaces).

Vendors must supply:

- Instructional and promotional materials
- Digital resources for virtual programs (e.g., PDFs, videos)
- Any specialized equipment (e.g., mats, utensils, tech) with listed costs in budget
